It is through this call that we are able to gather the information we need to offer a superior service to automated comparison sites. Online comparison tools often suggest policies that are not the best match, and may not be the lowest market price, because they can't ask key questions or get insight into your unique situation. For instance, some insurance providers price differently based on variables like BMI or existing health conditions. Comparison sites cannot check these automatically, so they ignore them. You subsequently can pay more than they said you would. They also can't check that the policies they suggest will accommodate pre-existing conditions, or cover non-funded drugs.
